The State Veterans' Commission has determined that the applicant has demonstrated the required financial need. Additionally, to assist the tax authority we have verified with the Department of Veterans Affairs that the applicant is totally and permanently disabled as a result of service connected causes incurred during a period of war or armed conflict. Therefore, it is recommended that the applicant be approved for the exemption of all real estate taxes on the above listed property.

If the application is a new claim, the qualified applicant shall be exempt from real property taxes that become due on or after November 6, 2023. You must present this letter to your local tax authority to determine the precise tax period from which you will be exempt. You should know that taxes are considered due on the first day of a tax period even though payment may not be due for several months.

The State Veterans' Commission is required to review all property tax exemption cases at least once every five years for determination of CONTINUED FINANCIAL NEED. A review form will be mailed to the applicant sometime prior to the due date for review.

ARP ESSER Health and Safety Plan

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. **Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.**

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Wyoming Valley West School District is committed to keeping students in school for in-person daily instruction as the optimal mode of operation. The District will prioritize the health and well-being of both students and staff in the delivery of instruction and the maintenance of its facilities. Hygiene and cleaning protocols that were established and developed during the 2020-2021 school year will remain in place at the school facilities. The District will develop and revise procedures and policies for the reopening and operation of school facilities as needed, considering information and guidance received from the Center for Disease Control, the Pennsylvania Department of Health, and the Pennsylvania Department of Education.

- 2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?**

The Wyoming Valley West School District will continue to develop a broad range of services to meet students' academic, social, emotional, and mental health needs. The District will utilize school counselors, outside agencies, and mental health programs, and provide in-service training on recognizing at-risk students to all professional staff. We will continue to provide free breakfast and lunch to all students throughout the 2023-24 school year.

f. Diagnostic and screening testing;	Students and staff are recommended to complete daily screenings and instructed on the signs and symptoms of illness.

Appropriate accommodations for students with disabilities with respect to health and safety policies; and	Wyoming Valley West will continue to offer a free and appropriate public education for all students. This includes providing appropriate accommodations for students with disabilities, including any necessary modifications with respect to our health and safety policies.
